Erasmus+ Key Action 1 - Youth Exchanges (YE) [link to full info here]

It is a meeting of groups of young people from **at least two countries.** Participants implement a project on jointly chosen topic (culture, diversity, and inclusion issues, etc.) by using non-formal methods (e.g., debates, exercises, role-plays, workshops) designed before the exchange. YEs are based on a transnational cooperation between two or more participating organizations from different countries within and outside the European Union. Participants' learning experiences are recognized through a <u>Youthpass</u>. The complete **Erasmus+ programme guide** (available in 23 languages) can be found <u>here</u>.

Participants

Groups of young people ages 13 to 30. Minimum number of participants is 16 and the maximum is 60. Each group must have at least one leader (an adult, no age limits).

Length of Exchange & Project

Exchange duration: 5 to 21 days (excluding travel time); Project duration: 3 to 24 months.

What will be covered?

- > Travel costs
- Organizational costs (flat rate per participant)
- > Costs of activities promoting the project and its achievements
- Additional costs related to the participation of persons with disabilities and with fewer opportunities or special costs (visas, residence permits, etc.)
- Costs of a two-day preparatory visit for up to two people from each organization

Programme Countries

- > 27 EU member states
- > non-EU countries: Iceland, Liechtenstein, Norway, Switzerland, Republic of North Macedonia, Turkey, Serbia, United Kingdom.
- ➤ neighbouring Partner Countries: Western Balkans (Albania, Bosnia and Herzegovina, Montenegro, Kosovo); Eastern Europe and the Caucasus (Armenia, Azerbaijan, Belarus, Georgia, Moldova, Russia, Ukraine); South-Mediterranean countries (Algeria, Egypt, Israel, Jordan, Lebanon, Libya, Morocco, Palestine, Syria, Tunisia)

Application

There are three deadlines to apply for grants during the year: February, April, October.

The next application deadline is <u>1 October 2020 at 12pm Brussels time</u> (for projects starting between 1 January and 31 May of the following year).

To be participate in Erasmus+ projects, organizations must have an Organization ID (OID). Each organisation involved in the application must:

- ➤ Have a representative register an organization must register in the <u>EU LOGIN system</u>.
- register through the <u>Organisation Registration system</u> (for actions managed by National Agencies) and receive an OID. Organisations that have a PIC and have previously applied for funding in the Erasmus+ or European Solidarity Corps programmes through the National Agencies should not register again they will be assigned an Organisation ID automatically.
- > check the compliance with the Programme criteria for the relevant Action/field.
- > check the financial conditions.
